e-Giving

Dear Parishioner,

The Parish Finance Council has established an e-Giving program in order to facilitate regular contributions to the weekly offertory and other scheduled collections. By utilizing this plan, your contributions will be automatically transferred from your checking or savings account to Holy Infant.

The e-Giving program at Holy Infant provides a simple, convenient and time saving service to parishioners and assists in the fulfillment of your stewardship commitment. Likewise, our parish benefits from the improved efficiencies and more consistent level of contributions typically associated with electronic funds transfers. Over one-third of our identifiable offertory contributors are now using the e-Giving plan!

To enroll, visit our parish website, Holyinfantchurch.org:

- Select "Give".
- Select "Create Profile" and follow the process to set up your profile.
- No other documentation is required.

Please remember that if you are converting from a weekly to a monthly donation, the weekly amount should be multiplied by 4.33 in order to provide the same annual contribution to the parish. For example, a \$30.00 weekly donation becomes a \$130.00 monthly (or \$65.00 semi-monthly) e-Giving transfer. We ask that you prayerfully consider increasing your stewardship commitment in order to help us meet the anticipated increase in costs associated with providing services to the parish.

Once you have enrolled in the e-Giving program, please continue using your weekly envelopes as an expression of your stewardship commitment by checking the box on the envelope marked "e-Giving."

FAQ's

Please consider signing up for e-Giving.

Listed below are a few frequently asked questions. If any additional information is needed, please contact the Financial Services Administrator, Kristi Beckert, at KristiB@holysinphantchurch.org or 919-973-0017.

Q. What is e-Giving?

A. Electronic giving is an automatic transfer program which allows you to make contributions without writing checks.

Q. What is the advantage of e-Giving?

A. It saves time and work! You also help the church stabilize its budget and save money.

Q. How is e-Giving automatically deducted from my account?

A. Once you authorize the transfer, your specified contribution is electronically transferred directly from your checking or savings account to the church's account.

Q. When will my contribution be deducted from my account?

A. On its due date. You never have to worry about forgetting a payment or mailing on time.

Q. If I do not write checks, how do I keep my checkbook balance straight?

A. Since your contribution is made at a pre-established time, you simply record it in your check register on the appropriate date.

Q. Without a canceled check, how can I prove I made my contribution?

A. Your bank statement gives you an itemized list of electronic transfers. It is your proof of contribution.

Q. Is e-Giving risky?

A. E-Giving is less risky than check contribution. It cannot be lost, stolen, or destroyed in the mail. It has an extremely high rate of accuracy.

Q. How much does e-Giving cost?

A. It costs you nothing and saves you time.

Q. Do I have to sign up for all the collections?

A. You can choose the collections you wish to sign up for. For example, you may only want to sign up for the first collection. You do not have to sign up for any other collections including the second collection. You may choose some or all of the collections.

Q. How do I sign-up or update my existing e-Giving?

A. You can conveniently sign-up or update your e-Giving donations through the parish website, holysinphantchurch.org, by choosing e-Giving on the homepage.
